Your union Amicus asked for them in a national pay claim submitted to Fujitsu in January this year.

Fujitsu have refused to discuss the national pay claim with your union Amicus and have as usual imposed the 2005 pay deal on employees.

Many of you have been given between 0% and 3%.

AS INFLATION IS RUNNING AT OVER 3% AT THE MOMENT - THIS REPRESENTS A PAY CUT IN REAL TERMS.

Help your union Amicus to press Fujitsu to provide a fair, equitable and open pay system. In Manchester (Man05), Amicus negotiates pay and conditions each year. Here Amicus is able to ensure decisions have to be justified, there is less room for unfair treatment, and the system is more transparent.

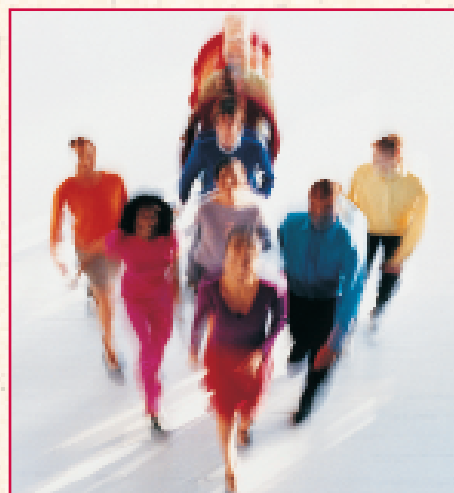
