The efforts of our members over recent years have now achieved a significant step forward. Amicus now have pay “comparator” figures for all the roles covered by our collective bargaining arrangement in Manchester. Whilst the disclosed grades are only those in the “collective pay bargaining group” we are confident that they also cover most staff throughout the country.

Amicus has this information and it is available to our members.
